### Minimum Qualification:

LL.B Degree with Minimum percentage of marks in qualifying examination shall not be below 45% (44.5% and above shall be treated as 45%) of total marks in case of general category applicants, and 40% ( 39.5% and above shall be treated as 40) of total marks in case of SC and ST applicants. Candidates who are awaiting results may also appear for admission test.

### Selection Procedure:

Admission to the above programmes are based on an admission test designed to test the aptitude for (i) teaching/research, (ii) comprehension, (iii) basic legal knowledge and (iv) legal reasoning.


