2. Only original essays will be considered for the competition. Previously published essays will be disqualified.
3. Any form of plagiarism will result in disqualification of the essay.
4. Co-authorship to a maximum of two authors is allowed.
5. The word count should range from 1500 to 1800.
6. The author(s) should adhere to the following format:
  - a. Font: Times Now Roman
  - b. Font size: 12 pt.
  - c. Line spacing: 1.5
  - d. Citation: any uniform style of citation
7. Cover of the written submissions:

- a. It should include name of the Participant, Address, e-mail id, Contact Number, Name of the College/University with address and email id.
  - b. The title of the document shall be super-scribed on the external cover/envelope containing the written submission.
  - c. List of References and List of Abbreviations shall also be submitted along-with the written submissions.
8. All submissions should be made in word document via an email to [timescape@klelawcollege.org](mailto:timescape@klelawcollege.org) with the subject 'Submission: TEWC - 2020'.
9. The author(s) are requested to mention a short bio within the body of the mail.
10. Names of the winners will be published on College website and a separate intimation will also be sent to each of the winner.

- a. Content Originality: 50 %
- b. Clarity: 20 %
- c. Overall impression: 20 %
- d. Structure: 10 %

- All participants will be awarded with a certificate of participation.
